Kids Cub Karts COVID-19 Safety Plan

1. Social distancing plan:

4 children will ride the go-karts and 4 children waiting only.

Children will exit on the opposite side of the track to the children coming in.

Children will be given ride instruction prior to getting in the go-kart.

Kids Cub Kart staff will only be in close contact if a kart has crashed for a short period of time to restart the go-kart.

Wherever possible stay 1.5 metres apart

2. Hand Hygiene plan:

Children to sanitise hands prior to go-kart activity and after go-kart activity.

Hand wash will be provided by the centre and available from Kids Cup Kart operator.

Kids Cub Karts will sanitise the steering wheel and surrounds after each rider.
