Children will put their hats on before leaving the OOSH building. Children without a hat will be given one from the Centre. • Children will be checked for drink bottles and asked to ensure all are filled prior to the activity. • Children will be given regular drink breaks throughout the day to ensure they remain hydrated. • Sunscreen will be applied to each child, where permission has been given & UV 3 or above. Serious Injury to a Child	Moderate	<ul style="list-style-type: none"> • Where a child has a serious injury, one staff member will render first aid, whilst the others move the other children away and ensure adequate supervision. Where an ambulance is required to be called, the staff member will notify the RPD, who will assist in calling the ambulance. Where a staff member leaving in an ambulance then compromises our child to staff ratio, and the activity is deemed unsafe with the number of remaining educators, the children will immediately be returned to the main room. Injury from Animal Bites During Feeding	Moderate	<ul style="list-style-type: none"> Educators will brief the children on the rules and expectations prior to the commencement of the activity Old MacDonald staff will teach the children how to feed the animals safely and will supervise all feeding sessions closely Children under the age of 10 will be assisted by Old MacDonald staff when feeding Any children who do not adhere to the rules will be removed from the activity. Injury from Handling Chickens Incorrectly	Moderate	<ul style="list-style-type: none"> The children will be taught how to pick up the chickens before entering the enclosure. Children will also be taught how to properly and gently return the chickens to the ground Chicken claws are clipped and soaked in solution every month by Old MacDonald staff to help soften them 	Educators/Children/Old MacDonald Staff	On Shift- At Centre
Infection Transmission from Livestock	Moderate	<ul style="list-style-type: none"> Children will be taught and reminded of the importance of not putting their fingers in their mouths after handling any animal and to wash their hands following time in the enclosure. NWOOSH Educators and Old MacDonald staff to ensure hand sanitiser is readily available around the enclosure All animals are drenched, washed and sprayed on a monthly bases in order to minimize any potential infection The floor of the enclosure will be covered in straw to absorb urine and faeces 	Educators/Children/Old MacDonald Staff	On Shift- At Centre
Injury from trips/falls over animals/ uneven ground	Moderate	<ul style="list-style-type: none"> Educators will conduct a thorough inspection of the proposed area during the daily WHS Check to ensure there are no hazards which may cause students to trip or fall Children will be reminded to take caution and be aware of their surroundings whilst inside the enclosure 	Educators	During daily WHS Check and On Shift

Injury due to child contact	Moderate	<ul style="list-style-type: none"> Educators will brief the children on the rules and expectations prior to the commencement of the activity Any children who do not adhere to the rules will be removed from the activity. No more than 12-15 children will be allowed inside the enclosure at a time Children will be advised to maintain a reasonable distance between them and their peers to ensure there are no collisions 	Educators and Children	On Shift- At Centre
Children being frightened by nature of the activity	Moderate	<ul style="list-style-type: none"> Children who are known to be easily frightened or suffering from anxiety will be placed close to supervising Educators and will not be forced to enter enclosure 	Educators/Children	On Shift – At Centre
Transmission of COVID-19	High	<ul style="list-style-type: none"> Educators and Old MacDonald staff to be fully vaccinated or have medical contraindication. Educators and Old MacDonald staff to ensure staff members displaying COVID-19 symptoms are removed from activity and sent home as soon as possible. Children who are displaying COVID-19 symptoms or are unwell will be removed from participating in the activity and parents will be phoned and advised to collect their child Children will be limited to 12-15 people at the enclosure at a time All educators, visitors, volunteers and Old MacDonald staff will sign in to the NWOOSH premises and have their temperatures taken and questionnaire answered prior to the commencement of the activity Old MacDonald staff will ensure all equipment including fencing and gates are sprayed with Glen 20 prior to and following all activities High traffic areas will be sprayed with Glen 20 periodically 	Educators/Children/ Old MacDonald Staff/Parents	On Shift – At Centre

OLD MACDONALD'S TRAVELLING FARMS – COVID SAFE PLAN

EQUIPMENT

At the start of each presentation all the tops of our fencing and entrance gates are sprayed with Glen 20 Disinfectant Spray, and again at the end of the day before the equipment is put back in the float. During the function and dependent on the length of time of the presentation, we will periodically spray high traffic areas at least twice with Glen 20.

If cups of feed are used at an event, they will have been disinfected prior to entry. After use they are put into a separate container to be cleaned before they are used by another person.

Our brushes are sprayed with Glen 20 regularly throughout a day

We have hand sanitizer for the public to use coming into and leaving the farm enclosure. This is clearly sign posted for the public to see.

FOR SOCIAL DISTANCING

We will endeavour to work with any special requirements you may have for your event.. If longer time is required to accommodate small groups, i.e. Childcare, this will be provided

Signage will be on the fencing to remind people of Social Distancing. We will control the number of people coming into the farm to maintain this rule to the best of our abilities.

Animals unfortunately don't understand social distancing!
