Policy Statement

We respect the right of individual parents to choose whether or not they immunise their children. However, children who are not immunised will be excluded for the period of an outbreak of a vaccine-preventable disease. Proof of immunisation will be sought on enrolment and will be kept on file with the enrolment form.

Procedure

Families will provide the Centre with a copy of their Immunisation History Statement (from the Australian Immunisation Register) on enrolment as evidence of child's immunisation status. Where an Immunisation History Statement is not available, the Centre will consider the child unimmunised. Once received, the AIR certificate will be kept on file with the child's enrolment form.

In the event of an outbreak of a vaccine-preventable disease at the Centre or school attended by children at the Centre, children not immunised will be required to stay at home for the duration of the outbreak, for their own protection.

In the event that any child or Educator contracts a vaccine-preventable disease, The Public Health Unit will be notified. The Public Health Unit may need to view the centres Immunisation Register to determine which children are at risk from the outbreak. Following review, the Public Health Officer may instruct the Nominated Supervisor to exclude certain children for a period, or may provide advice regarding preventative measures.

Under the NSW public health act 2010, the service must notify the following 9 vaccine preventable diseases to the local public health unit 1300 066 055

- Diphtheria
- Haemophilus influenzae type b (Hib)
- Measles
- Meningococcal C
- Mumps
- Pertussis (whooping cough)
- Poliomyelitis
- Rubella
- Tetanus.

Payment of fees will be required for children excluded during an outbreak of a vaccine-preventable disease.

All staff should also maintain through immunisation, their immunity to common childhood diseases.

Staff will be encouraged to undergo immunisation for Hepatitis B if they are not already immunised. Staff will be required to provide immunisation status on employment. In line with the immunisation policy, any staff member not immunised against a vaccine-preventable disease will also be excluded for the duration of an outbreak.

It is also recommended that all adults receive a booster dose of tetanus and diphtheria vaccine every ten years.
